Petitioner filed its Petition seeking to institute an *Inter Partes* Review of U.S. Patent No. 8,636,178 on March 30, 2017 using the Patent Trial and Appeal Board's electronic filing system. Petitioner was further informed that in order to obtain the filing date of March 30, 2017, Petitioner needed to reinitiate the payment procedure and file a motion seeking obtain the earlier filing date. Bailey Aff. ¶ 6, Ex. 1011. Petitioner was expressly advised that in order to receive the benefit of the earlier filing date, Petitioner would need to file a motion seeking to assign IPR2017-01216 a filing date of March 30, 2017. Bailey Aff. ¶ 6, Ex. 1011. Petitioner reinitiated payment and

received a filing date of April 11, 2017, and this motion followed.

Petitioner seeks an order of the Board assigning the filing date of March 30,

2017 to this IPR2017-01216. Petitioner properly filed its petition for inter partes

review, tendered full payment through its deposit account that was sufficiently

funded and otherwise complied with all the IPR filing requirements. But for an

internal computer error by the PTAB E2E fee processing system, Petitioner would

have been assigned a filing date of March 30, 2017. As the error was due entirely

to the actions and inactions of the PTO and through no fault of Petitioner, there is

good cause shown that Petitioner should be assigned the March 30, 2017 filing

date. Petitioner respectfully requests that the Board grant the motion and assign

IPR2017-01216 a filing date of March 30, 2017.
